

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to TheImageryCenter.com, and The Imagery Center, and Imagery Birthing Program, and governs data collection and usage.

For the purposes of this Privacy Policy, unless otherwise noted, all references to The Imagery Center | Imagery Birthing Program include TheImageryCenter.com and The Imagery Center.

The Imagery Center website is an Imagery Meditation venue designed to build and develop Self-Confidence, Self-Enhancement, and Self-Empowerment.

By using The Imagery Center website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Website, The Imagery Center may collect personally identifiable information, such as your:

- ❖ First and Last Name
- ❖ E-mail Address

If you purchase any Imagery Center downloadable MP3, general products and/or services, our payment processing center will collect billing and credit card information. This information security encrypted and only used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the website. - ❖ SSL Protocol
